

## Orange Home Grown Volunteer Release and Waiver of Liability Form

This Release and Waiver of Liability (“*Release*”) executed on \_\_\_\_\_ by \_\_\_\_\_ (“*Volunteer*”), releases Orange Home Grown, Inc. and Orange Home Grown Foundation (“*Nonprofit(s)*”) a 501c4 and 501c3 nonprofits organized and existing under the laws of the State of California as well as each of its directors, officers, employees, and agents. The Volunteer desires to provide services for this Nonprofit and engage in activities related to serving as a volunteer.

Volunteer understands that the scope of the Volunteer’s relationship with the Nonprofit(s) is limited to a volunteer position and that no compensation is expected in return for services provided by the Volunteer; that the Nonprofit(s) will not provide any benefits traditionally associated with employment to the Volunteer; and that the Volunteer is responsible for his/her own insurance coverage in the event of personal injury or illness as a result of their volunteer service to this Nonprofit(s).

1. *Waiver and Release:* I, the Volunteer, release and forever discharge and hold harmless this Nonprofit(s) and its successors and assigns from any and all liability, claims, and demands of whatever kind of nature, either in law or in equity, which arise or may hereafter arise from the services I provide to the Nonprofit(s). I acknowledge that this Release discharges the Nonprofit(s) from any and all liability or claim that I may have against the Nonprofit(s) with respect to bodily injury, personal injury, illness, death, or property damage that may result from the services I provide to the Nonprofit(s) or occurring while I am providing volunteer services.
2. *Insurance:* I understand that the Nonprofit(s) does not assume any responsibility for or obligation to provide me with financial or other assistance, including but not limited to medical, health or disability benefits or insurance of any nature in the event of my injury, illness, death or damage to my property. I expressly waive any such claim for compensation or liability on the part of the Nonprofit(s) beyond what may be offered freely by the Nonprofit(s) in the event of such injury or medical expenses incurred by me.
3. *Medical Treatment:* I hereby Release and forever discharge the Nonprofit(s) from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during my tenure as a volunteer with the Nonprofit(s).
4. *Photographic Release:* I grant and convey to the Nonprofit(s) all rights, title, and interests in any and all photographs, images, video, or audio recording of me or my likeness or voice made by the Nonprofit(s) in connection with my providing volunteer services to the Nonprofit(s).
